

ORDINANCE

**AN ORDINANCE AMENDING SECTION 218-54 OF THE CITY OF COATESVILLE'S
PARKING CODE TO PROVIDE FOR REGULATION (PARKING PERMIT OR
METERED PARKING) OF THE "THIRD AVENUE AND DIAMOND STREET
PARKING LOT" WITH DAYS OF OPERATION, HOURS OF OPERATION, PARKING
PERIOD LIMITS, AND FEES FOR PERMITS OR METERED USE ESTABLISHED BY
RESOLUTION OF CITY COUNCIL**

WHEREAS, the city of Coatesville is a Third Class City located in Chester County, Pennsylvania; and

WHEREAS, the City of Coatesville has recently upgraded and/or established a public parking lot in the City which is regulated by the City located at Third Avenue and Diamond Street fronting on Lincoln Highway with a general address of 251 East Lincoln Highway and which will hereinafter be known as the "Third Avenue and Diamond Street Parking Lot"; and

WHEREAS, in order to effectuate such regulation, an amendment to the Current Ordinance and City Code is required;

NOW THEREFORE, in consideration of the foregoing, the City of Coatesville does hereby amend Section 218-54 of the City Code governing metered, permit, and unrestricted off-street parking lots by the addition of the new subsection H as follows:

"H Third Avenue and Diamond Street Parking Lot


1. Location: (251 East Lincoln Highway).
2. Days of operation: To be established by resolution of City Council.
3. Hours: To be established by Resolution of City Council.
4. Parking Limit: Hours or permit periods to be established by Resolution of City Council.
5. Hourly Fee/Permit rate: To be established by Resolution of City Council."

All other terms of the City Code governing parking, including, without limitation, the procedures addressing violations and enforcement, shall remain in full force and effect.

If any portion of the Ordinance shall be determined to be unconstitutional, illegal or unenforceable, then the portion and only that portion of this Ordinance, which is deemed to be unconstitutional, illegal or unenforceable, shall be served from the remainder of this Ordinance and all other terms thereof shall remain in force and in full effect.


This ordinance shall be effective thirty (30) days after publication following final adoption in accordance with the City Charter and the Third-Class City Code.


