

**ORDINANCE 1348-2011
CITY OF COATESVILLE,
CHESTER COUNTY, PENNSYLVANIA**

AN ORDINANCE AMENDING CHAPTER 192 - SPECIAL EVENTS OF THE CODE OF THE CITY OF COATESVILLE, CHESTER COUNTY, PENNSYLVANIA TO ADDRESS "LEAGUE USE (BASEBALL)" AND THE FEES PROVISION IN CHAPTER 108 THEREOF TO PROVIDE FOR A LEAGUE USE FEE SUBJECT TO AMENDMENT BY RESOLUTION OF CITY COUNCIL

BE IT ENACTED by the Council of the City of Coatesville, Chester County, Pennsylvania, and hereby ordained by the authority of the same that Chapter 192 – Special Events, Paragraph 192 -6. – “Application and application fee”, and Chapter 108-1 U. “Parks and recreation fees” are both hereby amended and reenacted to provide for “League Use (Baseball)” to read as follows:

Section 1

Section 192-6 of Chapter 192 of the City Code entitled “Special Events” under the heading, “Application and application fee” is amended by adding an additional sentence at the end of the paragraph stating as follows:

“Applications for league use (baseball) shall be submitted prior to the season for which use is sought and shall identify the intended park for which use is sought by the baseball league, the time periods at issue, the days of use and the beginning and end of the proposed league use. All such applications shall pay an application fee sufficient to cover the costs incurred by the City for maintenance of the fields (including dragging and liming), as identified in Chapter 108-1 U of the City Code, subject to amendment by Resolution of City Council. The City shall seek to coordinate efforts to use the existing fields for baseball use with a priority given to those leagues which have historically used the fields in question. Every effort will be made to accommodate league schedules and to provide flexibility to allow other uses of the fields.”

Section 2

Chapter 198 of the City Code, entitled “Fees”, Section 108-1 U. “Parks and recreation fees:” is amended by the addition of a subsection under “Park” and “Hours” setting forth a heading “League Use (Baseball)” and identifying a cost per season as \$800.00 per season. This fee is subject to amendment by Resolution of City Council”

Section 3

All ordinances or parts of Ordinances inconsistent herewith are hereby repealed.

Section 4

This ordinance shall be effective thirty (30) days after publication following final adoption.
