

ORDINANCE

AN ORDINANCE AMENDING CHAPTER 108 OF THE CITY OF COATESVILLE'S CODE GOVERNING "FEES" TO PROVIDE AT SECTION 108-1 X. FOR: (1) RESIDENTIAL PARKING PERMITS (AND RENEWALS) AT TWENTY (\$20.00) DOLLARS PER MONTH OR ONE HUNDRED AND EIGHTY (\$180.00) DOLLARS PER YEAR, AND A TWENTY (\$20.00) TRANSFER FEE ; AND, TO PROVIDE AT SECTION 108-1 U. (9) A USE FEE FOR THE COATESVILLE MEMORIAL COMMUNITY CENTER OF THREE HUNDRED (\$300.00) DOLLARS FOR FOUR (4) HOURS OF USE, ONE HUNDRED (\$100.00) DOLLARS FOR EACH ADDITIONAL HOUR OF USE AFTER FOUR HOURS OF USE AND A REQUIRED ONE HUNDRED AND FIFTY (\$150.00) DOLLAR SECURITY DEPOSIT.

WHEREAS, the City of Coatesville is a Third Class City located in Chester County, Pennsylvania; and

WHEREAS, the City of Coatesville under Section 218-79 through 218-92 permits residential parking in certain areas of the City subject to Residential Permits and further provides that the fees for such Residential Permits (and related costs/fees for the renewal and transfer thereof) are to be at costs established by City Council as part of Chapter 108 of the City Code governing "Fees"; and

WHEREAS, the City has provided for the use of City Property known as the Coatesville Community Memorial Community Center located at 99 North Ninth Avenue, Coatesville, Pennsylvania which is used for various functions at prices which are also required to be identified in the City's Code at Chapter 108 governing "Fees".

WHEREAS, in order to effectuate such regulation, and provide appropriate fees for such permits or uses, amendments to the City Code are required;

NOW THEREFORE, in consideration of the foregoing, the City of Coatesville does hereby amend Chapter 108 governing "Fees" as follows:

- 1) Section 108-1 X. "Parking Escrow" is amended as follows:

The title is changed from "Parking Escrow" to "Parking".

The original section entitled "Parking Escrow: \$2,500 per parking space" is restated in its entirety as Section 1108-1 X (1);

A new Section 1108-1 X . (2) is added stating:

"(2) Residential Permits (a) \$180.00 per year and \$20.00 per month to permit parking in and only in either :1) the "Residential Parking Permit Area" or 2) the "Parking

Permit District” (as defined in Chapter 218, Article XIX of the City Code) for the ward in which the permitted party resides;

- (b) renewal fees as set forth in section “a” above;
- (c) \$20.00 transfer fee

2) Section 108-1 U. “Parks and recreation fees” is amended by adding the following: Section (9) stating as follows:


“Coatesville Community Center use fee: \$300.00 for four (4) hours; \$100.00 per hour after four (4) hours; and, \$150.00 security deposit”

All other terms of the City Code governing “Fees” shall remain in full force and effect.

If any portion of the Ordinance shall be determined to be unconstitutional, illegal or unenforceable, then the portion and only that portion of this Ordinance, which is deemed to be unconstitutional, illegal or unenforceable, shall be severed from the remainder of this Ordinance and all other terms thereof shall remain in full force and effect.

This Ordinance shall be effective thirty (30) days after publication following final adoption in accordance with the City Charter and the Third-Class City Code.
