

ORDINANCE 1434-2014

AN ORDINANCE AMENDING CHAPTER 108-1.I.(1) FEES IN THE CITY OF COATESVILLE TO ADDRESS USE OF CONTAINERS FOR COLLECTION OF ½ CUBIC YARD

WHEREAS, the City of Coatesville is a Third Class City situated in Chester County, Pennsylvania, operating under its Home Rule Charter and the Third Class City Code (hereinafter the "City"); and,

WHEREAS, the City has determined that it will collect solid waste in containers that hold ½ cubic yard of solid waste (and will also collect recyclables in a similar manner to provide for collection of all solid waste/recyclable needs of the citizens); and

WHEREAS, the City recognizes that in extraordinary circumstances a very large family or other unanticipated needs may require additional trash and recyclable pickup at a location – which such needs can be supplied as a double collection subject to a double billing.

NOW THEREFORE, in consideration of the forgoing, and its authority under the Third Class City Code and its Charter, the City of Coatesville City Council does hereby enact and amend Chapter 108-1 Fees to amend Section 108-1.I.(1) and (2) by removing them in their entirety and replacing them with the following language:

“(1) Up to one half (1/2) cubic yard of solid waste per week; \$295.00 per year per unit per parcel.”

(2) Where circumstances warrant a need for additional service, the person in need of such additional service meeting the qualifications for such service, shall be entitled to pay for an additional container and additional service as set forth in section (1) above at the same cost, upon paying for same and filling out an application form with the City and paying the additional administrative cost for processing the application in an amount of not more than \$10.00.”


This residential solid waste fee supersedes any and all inconsistent Ordinances or parts thereof which are hereby repealed or annulled.

Should any section, paragraph, clause or phrase of this Ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, the remainder of said Ordinance shall not be affected thereby, and shall remain in full force and effect.

This Ordinance shall become effective thirty (30) days after publication following final adoption in accordance with the City Charter and the Third-Class City Code.


