

RESOLUTION NO. 2011-10

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COATESVILLE
ACCEPTING BIDS FOR THE COLLECTION OF SOLID WASTE AND
RECYCLABLES WITHIN THE CITY LIMITS, AUTHORIZING THE AWARD OF A
CONTRACT TO THE LOWEST RESPONSIBLE BIDDER, EAGLE DISPOSAL OF PA,
INC. FOR A THREE YEAR CONTRACT \$384,000 (YEAR ONE), \$389,000 (YEAR
TWO) AND \$395,640 (YEAR THREE) WITH A PROVISION FOR TERMINATION BY
THE CITY AT ITS DISCRETION WITH ONE HUNDRED AND TWENTY (120) DAYS
PRIOR NOTICE BEFORE THE END OF ANY CONTRACT YEAR AND
AUTHORIZING THE INTERIM CITY MANAGER OR CITY MANAGER TO
EXECUTE THE APPROPRIATE CONTRACT AND ANY AND ALL NECESSARY
RELEVANT DOCUMENTS**


WHEREAS, the City of Coatesville had advertised for public bid certain work identified as the Collection of Solid Waste and Recyclables Within the City Limits, seeking bids for a base contract year and two one year options for a three year period; and

WHEREAS, on February 28, 2011, the City received and accepted three (3) bids in appropriate envelopes in response to the advertisement and these bids were publicly opened by the City Staff and have since been presented to City Council for consideration at a public meeting scheduled this 14th day of March, 2011; and

WHEREAS, the received bids have been reviewed by the City Manager and Staff and the City Solicitor, for purposes of determining compliance with the bid advertisement, the bid specifications and the law, and it has been determined that the lowest responsible bidder (and lowest bidder) for the project is Eagle Disposal of PA, Inc which has submitted a bid of Three Hundred and Eighty Four Thousand (\$384,000.00) Dollars (April 1, 2011 through March 31, 2012), Three Hundred and Eighty Nine (\$389,000.00) Dollars (April 1, 2012 through March 31, 2013), and. Three Hundred and Ninety Five Thousand Six Hundred and Forty (\$395,640.00) Dollars (April 1, 2013 through March 31, 2014).


NOW, THEREFORE, in consideration of the foregoing, the Council for the City of Coatesville accepts for consideration the bids submitted and received on February 28, 2011 and approves awarding a contract to Eagle Disposal of PA, Inc., as the lowest responsible bidder, for a three year contract subject to termination with one hundred and twenty (120) days advance notice by the City prior to the completion of any year of the contract; further, the City Council authorizes the Interim City Manager or City Manager to enter into an appropriate contract with Eagle Disposal of PA, Inc., and to execute any and all other necessary relevant documents.
