Board of Housing Appeals

Although its function is primarily to provide for reasonable interpretation of the provisions of the housing code, the board shall have the power to make variance and grant extensions of time in cases where strict enforcement of this code would cause undue or unnecessary hardship. All members must reside within the city limits of the City of Coatesville.

Board of Use Registration Appeals

The function of the Board of Use Registration Appeals shall be only to make determinations of legally existing nonconforming uses; it shall have no authority to establish or approve any new nonconforming use, grant variances or exceptions or to authorize any change in use. All members must reside within the city limits of the City of Coatesville.

Note: The members of the Appeals Board shall be qualified by training and experience to pass on matters pertaining to building construction. Training and experience may consist of licensure as an architect or engineer, a minimum of ten years of experience in the construction industry, and training or expertise as an inspection or plan reviewer and all applicants must have the qualifications according to Act 45 of 1999 in order to be eligible for appointment to the Appeals Board.

Members of the Appeals Board shall serve at the pleasure of City Council which shall appoint them. If a qualified person cannot be found within the City, the City Council may fill a position on the Appeals Board with a qualified person from outside of the City.

Zoning Hearing Board

Three person board appointed by City Council majority vote to three year terms. Up to three alternates may also be appointed by City Council majority vote. All members and alternates must reside within the city limits of the City of Coatesville and may not hold any other office in the City of Coatesville.
