

**ORDINANCE**

**AN ORDINANCE ESTABLISHING A FEE SCHEDULE UNDER CHAPTER 108-1(K.1) PUBLIC WORKS FEES TO COVER THE COSTS ASSOCIATED WITH PUBLIC WORKS PROJECTS IN THE CITY.**

**WHEREAS**, the City of Coatesville is a Third Class City situated in Chester County, Pennsylvania, operating under its Home Rule Charter and the Third Class City Code (hereinafter the "City"; and,

**WHEREAS**, the City has a Public Works Department and that department contributes to the safety and quality of life for residents and manages such duties as trash collection and recycling programs, snow and ice removal, and maintenance of public spaces; and,

**WHEREAS**, there are costs associated with maintaining the City, such as labor and equipment costs, incurred when the Public Works Department undertakes work with the use of its equipment; and

**WHEREAS**, the City has identified a need to establish a fee schedule to cover the costs associated with Public Works Projects within the City, costs which can be recovered when a Municipal Lien is imposed; and,

**WHEREAS**, the City has identified that actual costs incurred by the Public Works Department and currently has no ordinance in place to address these costs,

**NOW THEREFORE**, in consideration of the forgoing, and its authority under the Third Class City Code and its Charter, the City of Coatesville City Council does hereby enact under Chapter 108-1 Fees to establish Section 108-1(K.1) by including the following fees for work done by the City's Public Works Department:

“(1) Equipment: hourly rate (with a one hour minimum)

Bill air compressor	\$35.00
Backhoe 24"	\$50.00
Jackhammer	\$10.00
Concrete saw	\$10.00
Blade 16"	\$ 5.00
71" Mower	\$30.00
Skid Loader	\$30.00
16" Chain Saw	\$10.00
Dump Truck	\$35.00
Pickup Truck	\$25.00
Generator	\$12.00
Tamper	\$12.00

(2) Labor: Hourly Rate: \$51.00”

Should any section, paragraph, clause or phrase of this Ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, the remainder of said Ordinance shall not be affected thereby, and shall remain in full force and effect.

This Ordinance shall become effective thirty (30) days after publication following final adoption in accordance with the City Charter and the Third-Class City Code.


