

**ORDINANCE**

**AN ORDINANCE AMENDING CHAPTER 108-1.I.(1) FEES FOR COLLECTION OF SOLID WASTE PER UNIT PER PARCEL TO ADD A NEW SUBSECTION 1.I (a) ALLOWING FOR A \$5.00 REDUCTION IN THE YEARLY COST OF SAME WHEN THE ENTIRE BILL FOR SOLID WASTE IS PAID AT THE TIME FOR THE FIRST INSTALLMENT PAYMENT.**

**WHEREAS**, the City of Coatesville is a Third Class City situated in Chester County, Pennsylvania, operating under its Home Rule Charter and the Third Class City Code (hereinafter the "City"); and,

**WHEREAS**, the City collects weekly solid waste in containers that hold 1/2 cubic yard of solid waste for collection of all solid waste/recyclable for the needs of the citizens of Coatesville for a cost of \$295.00 a year per unit per parcel; and

**WHEREAS**, the City wants to reward the citizens of Coatesville who pay their solid waste bill in its entirety when first due and the first installment is due by giving them a \$5.00 reduction in cost of the solid waste bill.

**NOW THEREFORE**, in consideration of the forgoing, and its authority under the Third Class City Code and its Charter, the City of Coatesville City Council does hereby enact and amend Chapter 108-1 Fees to amend Section 108-1.I.(1) by adding a new Section 108-1.I.(1)(a) with the following language:


"(a) Each resident who pays their solid waste bill in its entirety when first due and by the deadline for a first installment payment shall receive a \$5.00 reduction in the yearly cost per unit per parcel."

Should any section, paragraph, clause or phrase of this Ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, the remainder of said Ordinance shall not be affected thereby, and shall remain in full force and effect.

This Ordinance shall become effective thirty (30) days after publication following final adoption in accordance with the City Charter and the Third-Class City Code.


