No private work will be done between November 15th and April 1st. Private work may be completed if approved by the city engineer or be needed due to emergency reasons should it fall in during the winter prohibited time frame. Work deeper than 1.5 inches shall be covered by steel plates during non-working hours. Plates should be steel and not less than 1" thick, with a 1' over hang on edges of roadway. They shall also be ramped by asphalt and secured in place by steel pins. During the winter season the plate shall be recessed by the depth of the plate and pins be secured in a manor not to create a hazard to possible plowing actions should it be needed due to weather.
